APPLICATION FOR STUDENT DEPARTURE FROM SCHOOL PREMISES

Please encourage your student to respect the rights of neighboring property owners and refrain from littering. Please caution your child against these thoughtless acts. If a student is found to be on private property, loitering or littering at these times, the student will be subject to revocation of the lunch/open campus pass and/or additional school restrictions. This is an effort to protect the privileges of the many well-behaved students from the misconduct of a minority of students.

1. Students in grade 12 and eligible 11th grade students are allowed to leave the school campus during lunch time and during periods 5, 6, or 7 if assigned to open campus, with both parental and school permission. Students must show required identification when departing the building and must sign out of the open campus assignment. If the student has open campus the period prior to lunch, he/she does not have to return to the building between those two periods. If open campus is after lunch, however, the student must return and sign out at his/her open campus study hall before leaving again. Students electing to leave school must do so within the first 5 minutes of the period and may not return until 5 minutes before the end of the period.
2. A student who, upon arrival at school in the morning by bus or private transportation, leaves the school premises prior to the start of homeroom is in violation of school regulations.
3. Students are not permitted to leave the school at any time during the school day without joint parent and school approval.
4. Any student trespassing on private property within a three block perimeter of the senior high school property between the hours of 7:00 a.m. and 3:30 p.m. may be subject to a fine for defiant trespass, without additional prior notice or civil complaint by the property owner.
5. Students reported loitering or littering off school property between the hours of 7:00 a.m. and 3:30 p.m. will be subject to borough ordinances regarding such behavior, as well as being subject to school disciplinary measures, including the loss of lunch/open campus pass.
6. No student is permitted to drive, ride, or sit in a car during school hours, including the lunch/open campus periods, even though the student is holding a valid pass.
7. When a student with a valid lunch/open campus pass leaves school, the school district's responsibility for the student's welfare is waived until the student returns to school.
8. Permission to leave school at lunch time/open campus time will be revoked by the school authorities for the reported violation of any of the above conditions. Additional disciplinary action may be taken in accordance with the school's disciplinary regulations.
