

BOYERTOWN AREA SENIOR HIGH SCHOOL
REQUEST FOR PERMISSION TO PARK AN AUTOMOBILE ON SCHOOL PROPERTY
2009-10

Parking spaces on school property are limited in number. As a result, eleventh and twelfth grade students who want to drive to school and park on school property must obtain a parking permit in the office. The permit will be issued only after this request is returned. There will be a \$50.00 fee for the parking permit. The school resource officer will assign permits up to the number of spaces available for student use. When students receive a permit they will be permitted to park only in their assigned space located in either the Bear Stadium lot, the two-level lot, or the lots behind the new auditorium and gym. Afternoon Career Tech students may not park in the band parking lot. Students may not park in spaces designated for faculty, visitors, or handicapped.

Handicapped spaces will be available for students who need to park close to the school because of medical problems. Those students should talk to the security officer for more information.

Students should use the Monroe Street entrances and exits to and from their parking lots. They are not permitted to drive through the faculty lots via Madison Street at any time.

Driving violations, excessive speeding or any misconduct involving students on the parking lots may result in revocation of students' parking permit. The school's smoking/tobacco possession rules apply to students who receive permits to park on school property. This includes driver and passengers. The fine for parking violations is \$15.00. Students who receive three tickets, or do not pay parking fines within ten school days will have their parking privileges revoked. Career Tech Center parking permits are not valid at BASH. Cars improperly parked, in a faculty space, or without a properly displayed permit will be ticketed and towed. **YOU ARE NOT PERMITTED TO GIVE YOUR PARKING PERMIT TO ANYONE ELSE. IF THIS OCCURS, BOTH STUDENTS WILL LOSE THE PRIVILEGE TO PARK ON SCHOOL PROPERTY.** Due to community use of BASH facilities, certain parking lots may be closed to accommodate such activities. In such cases, students will receive prior notice.
