The **Leidy-Rhoads Scholarship Foundation** is available to **ONLY residents living in the borough of Boyertown. The Frank and Amanda Hartman Educational Foundation is available to ONLY people residing in the townships of Colebrookdale, Douglass-Berks, Douglass-Montgomery and the borough of Boyertown.** Applicants may apply yearly for a total of **four years** of undergraduate work. The Hartman Foundation is only applicable when attending a college or university for undergraduate work.

In addition to completing the attached application, the following documents must be submitted. If you are in your first or second year of college and have never received financial aid from either of these foundations, you must submit your high school transcript in addition to the college transcript. All information will be held in strictest confidence.

- _____ Complete Official Transcript including principal's signature and official school seal
- _____ Copy of the third marking period report card.
