2023-24 Homestead/Farmstead Property Tax Relief

- Provided for by Act 1 of 2006 and Act 25 of 2011
 - Provides tax relief to eligible homeowners
 - Funded by state gaming revenue
- Total Eligible Homestead/Farmstead Properties:
 - Berks: 5,281
 - Montgomery: 6,923
- Total Tax Relief per Eligible Property
 - \$176.96



2023-24 Proposed 3% Real Estate Tax Increase – Impact on Property Owners

Annual Real Estate Tax Increase over 2022-23	\$ 44.54	\$ 66.97	\$ 134.24



Real Estate Tax Installment Plan

- May 27, 2014 June 30, 2020
 - Three equal installments: July 31, September 15 & October 31
 - 2% discount provided if paid in full by August 31
 - 10% late fee if not paid in full on or before October 31
- 2020 2022 Tax Levy (2020-21 thru 2022-23 School Years)
 - Four equal installments: July 31, August 31, September 30 & November 30
 - 2% discount provided if paid in full by August 31
 - 10% late fee if not paid in full on or before October 31
- 2023 Tax Levy Installment Plan Recommendation
 - Four equal installments: July 31, August 31, September 30 & October 31
 - 2% discount provided if paid in full by August 31
 - 10% late fee if not paid in full on or before October 31
