Multiple Occupancy Affidavit Renewal

When enrolling a child/children in the Boyertown Area School District, it is necessary to establish residency. The Multiple Occupancy Affidavits are used when the parent(s) and child(ren) to be enrolled are residing with a person who owns or rents a property in the Boyertown Area School District borders.

The Boyertown Area School District requires that those students in attendance under a Multiple Occupancy status within the boundaries of the Boyertown Area School District to update their Application of Multiple Occupancy annually.

To remain in accordance with this requirement, the Boyertown Area School District is asking that you and the homeowner/renter complete an updated affidavit and return them to the office where your child attends. You do not have to provide additional Proofs of Residency, just the **notarized affidavits**.

Attached you will find a Multiple Occupancy Affidavit which will be used to establish your residency in this District.

Please complete the following steps:

- 1. Complete "Certification of Multiple Occupancy by Owner/Renter" (this form is to be completed by owner/renter).
- 2. Complete "Affidavit of Residence" (this form is to be completed by person attempting to establish residency).
- 3. All forms must be notarized.
- 4. All forms returned to the student's current school.

If you have any questions regarding the procedure listed above, you may contact the main office where your child is to attend school.
