- 2. The Pledge of Allegiance and a moment of silence were observed.
- 3. There was one comment made during Public Comment Period # 1 by Ms. Linda Curry regarding the agenda items and wanting to hear more regarding them.
- 4. The committee accepted the February 26, 2013 minutes by a 6-0 vote. Voting in favor of the minutes were: Mr. John Crossley, Ms. Ruth Dierolf, Mr. Steve Elsier, Mr. Joseph Nichols, Mrs. Gwen Semmens, and Mrs. Donna Usavage.

- 6. Mr. Katch made a presentation to the committee regarding the Safe Schools Software. Mr. Katch provided background information on Safe Schools, the courses offered, tentative investment and benefits. This form will allow Safe Schools to develop a formal price discount for the consortium. The software would replace our current training software and at a lower price to the District.

7. Mr. Katch and Administration presented to the committee a proposal to hire a girls golf coach at BASH. With the start of the 2013-2014 school year, the PAC 10 will have increased opportunities for girls golf and for the past three seasons BASH has fielded the required numbers to be considered a full team according to the PAC 10 by-

laws. After much deliberation, the committee decided to table the discussion pending a review of the situation by the solicitor.
