UPDATED ATTENDANCE POLICY

(as per the federal government's Every Student Succeeds Act)

1. Parents/guardians may send an email to attendanceGES@bovertownasd.org from the email address of the parent/guardian on file with the district by 9:00am on any day that their child will be absent or tardy. This form of communication will not need a phone call or follow-up hand written note.
2. Parents/guardians may use the district website/app and fill out the absence note by 9:00am on any day that their child will be absent or tardy. This form of communication will not need a phone call or follow-up hand written note.
3. Parents/guardians may call the attendance line at 610-369-7518 by 9:00am on any day that their child will be absent or tardy. **However, absences must now also be followed up with a handwritten parent note or doctor's note within three days of the student's return to school.** Failure to submit the appropriate note within three days will result in the absence being coded as unlawful, and this coding cannot be reversed even if a note is handed in after the three day window. Once a student has received three unlawful absences, a truancy elimination plan may be enacted. This plan could lead to a citation from the District Magistrate.

PRINCIPAL'S CORNER – Thank you for the great start to another school year. I hope that your summer has been an enjoyable, restful one and that your children are as eager as we are to begin a new school year!

Your child(ren) will bring home various items for you to read and return. Please exercise patience and carefully read the materials. While this process can be time consuming, it provides us with critical information for our students. Promptly return the items which need to be brought back to school.

For the safety of our children, I would like to review our security procedures:

- All doors are locked, and everyone must enter through the main doors. You must press the button on the gray box on the left side of the door. When greeted, give your name and purpose of visit. After entering the first set of doors, make an immediate left into the office entrance. Please bring a photo I.D.
- Visitors and volunteers must report to the office before going to the classroom areas. You will need to secure a badge in the main office area. Our Raptor system will be used to further screen those gaining access to our school. Clearances are still required for volunteers in accordance with district policy. Please visit the district website for more information regarding the FBI fingerprinting procedures.

VISITORS TO GES – All visitors (including parents) must report to the office upon entering the building. I would like to review the procedures to follow when entering GES. These procedures pertain to the school day except for the end of school pick up when parents enter through the outside library door.

1. All adults (alone or accompanying children) must enter at the main office entrance. **PARENTS BRINGING CHILDREN INTO THE BUILDING IN THE MORNING MUST ENTER THE MAIN ENTRANCE DOORS RATHER THAN THE STUDENT DROP-OFF DOORS.**
2. If volunteering or visiting, the secretary will issue you a badge. Be sure to bring your driver's license on your first visit for scanning into the Raptor system. Volunteers should have clearances on file in the office.

Before visiting with a teacher, an appointment must be made. This will help minimize classroom interruptions. Please be reminded that these procedures, with your cooperation, help ensure the safety of our children.

I thank you in advance for your cooperation and support in implementing these procedures.

Clear, effective communication between home and school is an important aspect of every child's education. We strongly encourage parents to communicate regularly with teachers and other appropriate school personnel to foster openness, understanding, and a team commitment to academic success. REMINDERS –

Daily Opening – Children may be dropped off after 8:25 a.m. Do not drop your child(ren) off before 8:25 a.m. because we are unable to supervise them. Please remember that each school day begins promptly at 8:45 a.m. **The Parent Drop Off door will close at 8:40 a.m.** This allows the student time to walk to class and arrive by 8:45 when attendance is taken. A student being transported by private vehicle who arrives after that time will be considered tardy. The student must accompany the adult to the office to be signed in before reporting to class. Be sure to sign in the appropriate time that the child arrives at school.

****NEW INFORMATION REGARDING BUS PASSES:** Bus runs no longer have much room for emergency bus passes to be granted. If there is a true emergency requiring a student to ride a different bus one day, permission from the transportation department must be obtained by the office staff before being able to grant a bus pass. Most times they will not be able to approve them due to limited space.

Free or Reduced Price Lunch - Applications are available on the BASD website for those who qualify and wish to take advantage of this opportunity. **If you received free or reduced lunch last year, you must reapply this year before October 14. Applications for applying and re-applying are done online.**

Weapons and Threats -- Parents, as we embark on a new school year, please remember that pocket knives or other objects considered as weapons are prohibited in the school setting. This includes toys that look like weapons. Students in possession of such objects will face severe consequences. Also, please emphasize with your children that threats about “killing” will also result in severe consequences. Again, I thank you for your continued support.

Student Photographs – About two weeks before student photographs are taken, you will receive information regarding the taking of individual photographs. As a service to parents and to raise funds for the Activity Account, the district has contracted with Lifetouch Studios. There will be various

options and payment is required on the day of the photographs - **Thursday, September 5**. All students will have their pictures taken for school record purposes.

PEEP Classes -The parents of children who attend PEEP classes will receive necessary information concerning arrangements before the classes begin. Schedules are also available on the BASD website.

Student Accident Insurance -- If you are interested in purchasing Student Accident, Life, and/or Dental Insurance, you are directed to go to www.BollingerSchools.com for more information.

Full Time Health Room Coverage -- All schools in the district have a certified school nurse or staff nurse on duty at all times. If you wish to speak with our health room staff, please call 610-473-5070 during school hours.

Animal Restrictions -- We have restrictions concerning animals in the classroom. Students having allergies, as well as animals being unpredictable, have caused us to be more cautious. If you have any questions, please direct them to me rather than your child's teacher.

School-Wide Rules and Consequences -It is necessary that children learn to develop self-discipline. We ask that you discuss with your child(ren) the importance of and need for appropriate behavior and a positive attitude while at school.

The schools are established for the benefit of all students. The educational purpose of the schools is accomplished best in a climate where student behavior is socially acceptable and conducive to the learning and teaching process. Student behavior which disrupts the process or which infringes upon the learning of other individuals will need to be corrected. Our school-wide expectations are:

Use kind words and actions.

Need to keep hands, feet, and objects to yourself.

I will follow staff directions the first time given.

Take responsibility for your actions and learning

Yield and walk silently in the hallways.

"PATRIOT'S DAY" – SEPTEMBER 11 -- Students who are Boy Scouts or Girl Scouts are invited to join in leading the Pledge of Allegiance and announcements during our morning opening on Monday, September 11. They are welcome to wear their uniform to school.

EDUCATIONAL TRIPS -- District policy permits students to be absent a maximum of ten (10) days per year to accompany parents on educationally worthy trips upon written request. Although permitted, we do not encourage absence from school. The activities of the classroom can never be fully made up. Please give serious consideration before planning extended absences during school time. Forms must be submitted at least 2 days in advance of the trip. **FAILURE TO SUBMIT A TRIP FORM PRIOR TO DEPARTURE WILL RESULT IN TRIP DAYS BEING COUNTED AS AN UNLAWFUL ABSENCE!** Trip forms continue to be available in the school office as well as on the BASD website:

Student Departure - Kindergarten students will not be permitted to leave a school bus or van without a parent/guardian or designated person for said student at the specified stop. An alternate to having a responsible person at the stop, is to have an appropriate written arrangement with the school district's Supervisor of Transportation (610-473-3473).

Students in first grade and higher will be permitted to leave a school bus or van at a designated stop without the presence of an adult to accompany the child. No other arrangements will be made for Gr. 1 students, or other students in higher grades.

A time of concern is at the close of school. Parents are to wait in the library for the dismissal of children being picked up. Students are not to be picked up in the lobby or outside classrooms. The library provides an area where the student pick-up can be monitored. Pick up at dismissal begins at 3:25 daily, followed by bus dismissal.

EARLY DISMISSALS – On September 25th, we have a 12:30 p.m. early dismissal.

The Kindergarten schedule is as follows on early dismissal days:

AM Kindergarten—8:45 a.m. to 10:30 a.m. **PM** Kindergarten—10:30 a.m. to 12:30 p.m.

PICK-UP NOTE REMINDER – Parents, when filling out parent pick-up notes, please include the full name of the person picking up your child, instead of “grandma” or “aunt”. This will avoid confusion at dismissal. Thank you!

News from the Nurse

August/September Newsletter:

Welcome back to school. We need your assistance to support the safety of our students. Please complete the Infinite Campus Parent Portal. You should have received a separate email regarding passwords to access this system. Please update all demographic, medical, and medication information needed for the school year. (A parent/ guardian signature is required for your child to receive services in the health room, this is now in electronic form.

With the start of the new school season please remember to send along a water bottle and appropriate clothing for your child to get through the school day. On very hot days the children need to remain hydrated throughout the day. Please help us by giving them a water bottle to keep at their desks.

Please contact your health care provider to determine if your child needs any immunizations. Notices were mailed to parents if immunization documents currently on file for their child do not have the appropriate immunizations. If you do not receive a notice, your child's immunization records are up to date. Please see below for new immunization regulations.

Physicals/Dentals: The PA School Health Act requires dental examinations for all students entering Kindergarten and third grade, and physical examinations for students entering kindergarten in the 2019-2020 school year. Physical and dental exam forms may be dated no earlier than one year prior to September 1st; therefore, forms submitted must be for exams that occurred on or after September 1, 2018. Please contact the health room if you need a physical or dental form for an upcoming appointment or you can download forms at any time from the BASD website @ <http://www.boyertownasd.org/> under Services - Student Services - Health. Please submit completed physical and dental forms for these grade levels by May 1, 2020.

Medications at school: please refer to the BASD medication policy if your child needs to take medications during school hours. All medications, over-the-counter, herbal, and prescribed, require a written order from a doctor and written parent permission to be administered to a student by the school nurse. Medications must be delivered to the school nurse by a parent or adult designee. Medication authorization forms are available on the BASD Web site @ <http://www.boyertownasd.org/> under Services - Student Services - Health or by contacting the health room.

Head Lice: September is National Head Lice Prevention month. During each school year, almost without fail, we can expect to find some cases of head lice among our students. To effectively manage head lice infestations in our schools, the Boyertown Area School District requires students with head lice or nits to be excluded from school and be readmitted when the school nurse determines the students are lice and nit-free. Information about head lice can be accessed on the BASD website under Services; Student; Health link. Prevention and control of head lice begins in the

home. Please help us prevent head lice by following the policy and checking your children often. If your child gets head lice, please contact the health room so we can assist you and your child.

New Immunization Requirements: The Pennsylvania Department of Health has issued new immunization requirements effective August 1, 2017 for the 2018-2019 School Year. Therefore, on the first day of school, your child must have all completed immunizations or a medical plan indicating the completion of the immunization series within the first five days of school or risk exclusion. Please note those immunizations that need only one dose must be completed by the first day of school. Your Certified School Nurse will contact you if your child requires further immunizations to meet the new state requirements.

- 4 doses of tetanus, diphtheria, and acellular pertussis*

(1 dose on or after the 4th birthday)

- 4 doses of polio (4th dose on or after 4th birthday and at least 6 months after previous dose given)**

- 2 doses of measles, mumps, rubella***

- 3 doses of hepatitis B

- 2 doses of varicella (chickenpox) or evidence of immunity

*Usually given as DTP or DTaP or if medically advisable, DT or Td

** A fourth dose is not necessary if the third dose was administered at age 4 years

or older and at least 6 months after the previous dose

***Usually given as MMR

7TH Grade Entry:

- 1 dose of tetanus, diphtheria, acellular pertussis (Tdap) by the first day.

- 1 dose of meningococcal conjugate vaccine (MCV) by the first day.
